## ADVERTISEMENT OF INVITATION FOR BIDS

Sealed proposals addressed to the Honorable Mayor and City Council of the City of Lamesa, Texas, will be received at the office of the City Manager, City Hall, 601 S. First Street, Lamesa, Texas 79331, until **September 1, 2009, 5:00 p.m.**, for new groundwater monitoring wells at Lamesa's MSW Landfill (TCEQ #517A). Bids will be opened and publicly read aloud in a special called City Council meeting later that same evening.

All work described will be for the City of Lamesa, Texas. The sealed bid shall clearly state on the face thereof: "Proposal for the City of Lamesa, Municipal Solid Waste Landfill – Groundwater Monitor Wells."

Following the closing time for receipt of bids, proposals will be publicly opened and read aloud. Any bid received after closing time will be returned unopened.

Bidders must submit a Cashier's or Certified Check issued by a bank satisfactory to the Owner, or a Proposal Bond from a reliable Surety Company, payable without recourse to the order of the City of Lamesa, in an amount not less than five percent (5%) of the bid submitted as a guaranty that the Bidder will enter into a contract and execute bonds and guaranty in the forms provided within ten (10) days after notice of award of contract to him. Bids without the required check or Proposal Bond will not be considered.

The successful Bidder will be required to furnish a Performance Bond and a Payment Bond, each in the amount of the contract, written by a responsible Surety Company, authorized to do business in the State of Texas, and satisfactory to the Owner, as required by Article 5160, V.A.T.C.S., as amended by H.B.344, passed by the 56th Legislature, Regular Session 1959 and Experience Record.

BIDDERS ARE EXPECTED TO INSPECT THE SITE OF THE WORK AND TO INFORM THEMSELVES REGARDING ALL LOCAL CONDITIONS.
